Terms of Agreement

1. Services:

Service Provider agrees to provide the following services to the Client:

- i. Verification: Service Provider will verify the quantity, quality, and originality of the very important products being shipped to or from the Client.
- ii. Inspection: Service Provider will conduct inspections to ensure compliance with the specified standards, requirements, and regulations.
- iii. Preparation for Shipping: Service Provider will assist in the preparation of the very important products for shipping, including packaging, labeling, and documentation.

2. Fees:

Client agrees to pay Service Provider a fee equal to 1% of the invoiced value of the goods to verify, inspect, and prepare for shipping, with a minimum of EUR 300.- per shipment. These fees exclude any transportation or insurance costs for incoming or outgoing goods. The fee shall be paid to release the goods to the buyer. All payments shall be made in EUR unless otherwise agreed upon in writing.

3. Term:

- ii. Service Provider shall maintain the confidentiality of all information received from the Client in connection with the services provided.

5. Limitation of Liability:

Provider's liability for any loss, damage, or injury arising out of or in connection with the services provided under this Agreement shall be limited to the total amount of fees paid by the Client for the shipment of the goods received or to be sent to the Client and does not include the value of the goods. The value of the goods are covered by the warehouse during storage and by the transport insurance during shipping.

6. Governing Law and Dispute Resolution:

This Agreement shall be governed by and construed in accordance with the laws of the Czech Republic. Any disputes arising under or in connection with this Agreement shall be resolved amicably through goodfaith negotiations. In the event of failure to reach a resolution, the dispute shall be submitted to the exclusive jurisdiction of the courts of the Czech Republic.

7. Entire Agreement:

This Agreement constitutes the entire understanding between the Parties with respect to the subject matter hereof and supersedes all prior agreements, understandings, and representations, whether oral or written. Please indicate your acceptance of the terms and conditions set forth in this Agreement by signing and returning a copy of this Agreement. Upon receipt of the signed Agreement, Provider shall commence the services.
